The session was opened, and the existence of a legal quorum was verified, in accordance with Article 26(1) of the Statute of the Scientific Research Career, approved by Decree-Law no. 124/99 of 20 April, in its current wording (hereinafter ECIC) and Article 19(2) of the Regulations for the Recruitment, Hiring and Service of Scientific Research Personnel of the University of Coimbra, Regulation no. 810/2021 (hereinafter RRCPSPICUC). Pursuant to Article 19(2) of the Regulations for the Recruitment, Hiring and Service Provision of Scientific Research Staff of the University of Coimbra, Regulation no. 810/2021 (hereinafter



RRCPSPICUC), the President of the Jury informed the members that the purpose of the meeting was to apply the two selection methods set out in point V. of the opening notice, namely approval on absolute merit and assessment of the candidate's scientific and curricular career through application of the selection criteria, culminating in the draft final ranking list.

He has managed research funding as a PI in personal projects, but he lacks experience in the coordination of a laboratory. The candidate presents a solid project in metacognition that can contribute to the production of important results in cognitive science and in the beginning of a strong line of research at Coimbra University.

In light of the suitability to the area and subareas (Psychology / Cognitive Neuroscience) and the evaluation parameters specified in the official call, the analysis of the application materials led to the assessment as follows.

Dr. Mikhail Ordin earned a PhD in Mathematical Linguistics in 2007 and, since then, he has led a successful international research career in the domain of Cognitive Psychology and Cognitive Neuroscience with stays in some of the most high-profile labs worldwide. He has published in major scientific journals, both general (e.g., Annals of the New York Academy of Sciences) and area-specific (e.g., Scientific Studies of Reading). His scientific project on "metacognition and decision making in neurotypical and atypical populations across cultures" is very ambitious, yet well-grounded in previous conceptual and methodological advances — a crucial pre-requisite to attain one of the project goals of bridging fundamental research to clinical work.

In addition to research proper, Dr. Ordin has had experience in organising lab facilities, granting funding, and in editorial service. His experience in supervising advanced studies is comparatively modest, but shows signs of increasing. Similarly for his participation in management bodies and community service.



Overall, Dr. Ordin's CV includes activities that respond very aptly to all of the criteria put forward in the call and hence fulfils the conditions for the position of Principal Researcher in Psychology / Cognitive Neuroscience at the University of Coimbra.

Final Report

This final report, containing the identification of the candidate(s) admitted and subsequently approved on absolute merit in the above-mentioned tender procedure, was drawn up under the terms of no. 3 of art. 27 of the Statute of the Scientific Research Career, in its current wording, and no. 3 of art. 29 of the Regulations for the Recruitment, Hiring and Service Provision of the University of Coimbra, Regulation no. 810/2021, as a result of the votes cast by the members of the Jury, as a result of the votes presented by the members of the jury, during a meeting held on 17th September 2024.

The Notice no. 2673/2024, published in Diário da República, 2nd series, no. 24/2024 of February 2, advertised the opening of an international competition to fill a post in the scientific research career, in the category of Principal Researcher, for the disciplinary area of Psychology, sub-area of Cognitive Neuroscience, of the Faculty of Medicine, authorised by order of the Rector dated October 30, 2023.

Three applications were submitted.

On 23 March 2024, the Jury for this tender met, deciding to admit the candidate Mikhail Ordin and not to admit the candidates Cees van Leeuwen, for, under the combined terms of points IV.2.5. and IV.5 of the Public Notice, not having submitted the Scientific Project for the next 5 years related to the research lines in the scientific field for which this tender is open to which the candidate proposes to dedicate himself in the University of Coimbra, further justified by the candidate's explicit declaration that he intends to pursue ongoing research in the next 5 years at his Laboratory at KU Leuven., and Lívia Valentin, for not complying with the special admission requirements set out in point III.2 of the Public Notice, and in article 11 of the ECIC, namely for not holding a PHD in the scientific area of the tender or in a different area, but with a relevant scientific curriculum in those areas and, in either

case, have a minimum of three years of professional experience in those areas after obtaining the PHD or have been approved in public qualification or in the academic title of Habilitation – Agregação -.

At the same meeting, the Jury drew up the list of admitted and excluded candidates, which was published on the University of Coimbra's electronic platform for managing tender procedures, Apply UC, and the candidates were notified of it under the terms and for the purposes of Article 121, ss of the Code of Administrative Procedure. No allegations were made during the hearing period.

The candidates were notified of the approval of the List of Admitted and Excluded Candidates.

On the 17 September 2024, the Jury met and decided that the candidate admitted - Mikhail Ordin - should be approved on absolute merit, as it considered that, in addition to meeting the minimum requirement set out in point IV.2. of the public notice, he had a curriculum vitae indicating an overall scientific activity appropriate to the position to be filled, demonstrated by compliance with the various parameters defined in the notice, valued qualitatively and quantitatively, and professional experience and training compatible with the category and scientific area for which the tender is open. At the same meeting, the Jury also assessed the candidate's scientific and curricular background in accordance with the terms of the public notice, drew up the Final Ranking List and the Final Report.

Each member drew up their individual ranking proposal based on the methods, selection criteria and assessment parameters set out in the Public Notice.

The members of the jury gave the candidate very close marks and generally considered that the candidate has a vast scientific output appropriate to the area of the tender, in different research centres and in several countries. The Jury also considered that the candidate has published in important scientific journals, has contributed to projects financed with national and EU funds, has published in prestigious scientific journals and has several publications as 1st author, has generated research funds as the Researcher in Charge, has successfully raised funding for the institutions where he has worked, and his project in the area of metacognition is capable of contributing to important results in the area of the competition and to a strong line of research at the University of Coimbra.
